Gentlemen and Ladies:

The taxpayer is in receipt of your letter of inquiry dated August 4, 1997.

The taxpayer did not receive a first notice from your department regarding the Company's filing requirement. The taxpayer, like a large majority of Florida small business taxpayers, does not, and did not, realize a filing is needed unless prompted by receipt of a Corporation Annual Report. The taxpayer also asserts that the second notice did not arrive until after June 30, 1997, and that the second notice report was promptly completed, signed and mailed with a check for \$165.00.


Accordingly, your office has returned the report and check with your penalty letter.

While I realize that ignorance of a filing requirement is not considered an excuse for non-filing or untimely filing, I find it difficult to accept the assessment of a 233 percent penalty for late filing when **no first notice was ever received.**

As mentioned above, many small businesses depend upon receiving tax forms as their reminder or tickler system. The burdens of operating a small business are immense since most small business budgets require the owner/employee(s) to assume many varied responsibilities in addition to trying to operate a profitable, cash flowing business venture.

On the taxpayer's behalf, and at their insistence, I respectfully request that the \$385 penalty be waived, since the taxpayer made every reasonable effort to file this report given these individual circumstances. The taxpayer and I will await your response.
