

### **ARTICLES OF MERGER**

Pursuant to the provisions of Section 607.1105, Florida Statutes, NORMAN & NORMAN, LLC, a Florida limited liability company, and TAPESOUTH, INC., a Florida corporation, hereby submit the following Articles of Merger:

#### **ARTICLE I**
