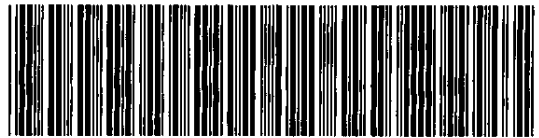


Pursuant to Sections 607.1001, 607.1004, 607.1006, and 607.1009, Florida Business Corporation Act, the following provisions of the Articles of Incorporation of Pest Control Depot, Inc. of Panama City, a Florida corporation, filed in Tallahassee on June 22, 1993 be and they hereby are amended in the following particulars:

Article I be, and it hereby is, amended to read as follows:

"The name of this corporation is **"Campbell Panama City Holding, Inc."**

The foregoing amendment was adopted by the Stockholders and Directors of the corporation on the 31th day of March, 2010. The only voting group entitled to vote on the adoption of the Amendment consists of the holders of the corporation's common stock.
