

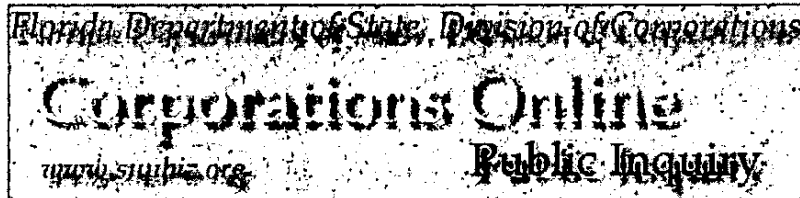

Article I is hereby amended to read as follows: The name of the corporation shall be:

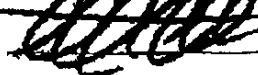

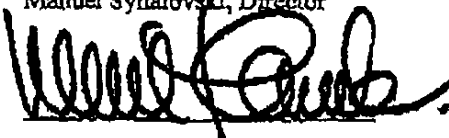
