The dissolution of the Corporation was authorized on March 28<sup>th</sup>, 2000.

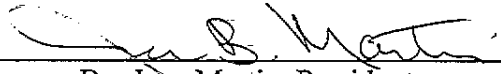
ARTICLE III - APPROVAL OF DISSOLUTION
