The above captioned taxpayer asked me to have this letter be written to you in response to the receipt of the notice of administrative dissolution.

As you may confirm in the enclosed copy of the business check stub, on April 20, 1998, the taxpayer mailed the annual report together with a check of \$ 150. (Check number # 6405). However, the check was not canceled as of today and, due to his family problems, he did not reconcile his bank statements whether the check was cleared through the bank or not.


Actually, his son has been suffering from a leukemia and blood disease and for the last eleven months, Mr. Woo Yung Kang's concern was centered around his son's health matters, even though he had to run the restaurant business at the same time.

Presently, he could not figure out the reason for the fact that the mail was lost and check could not be found along with the annual report. To verify the facts above, I am herewith enclosing the copy of the check stub showing the check # 6405 and the copy of the company's general ledger prepared on May 15, 1998.

In consideration of the reasonable cause described above, we are respectfully requesting you to abate the renewal penalty and please advise the taxpayer appropriately.
