Dear Sir or Madam:

Our firm represents CDS Holdings I, Inc. and CDS Holdings II, Inc. (hereinafter collectively referred to as the "CDS Companies"). We understand that the CDS Companies were involuntarily dissolved effective October 4, 2002 for failure to file annual reports with the Secretary of State. We would like to provide an explanation to the State as to why the CDS Companies were inadvertently and involuntarily dissolved. In addition, we request that both corporations be reinstated without penalty.

The sole officer and director of the CDS Companies, Christiane Marchesa Serra, resides in London. The CDS Companies' principal place of business and mailing address are located in Miami, Florida as evidenced by the records maintained by the Secretary of State. Unfortunately, the local representative of the CDS Companies, Cynthia Frias, who received all mail for the CDS Companies and was responsible for filing all annual reports and maintaining the corporate status for both corporations, recently passed away. Ms. Frias became seriously ill during the early part of this year, suffering from severe asthma and bronchial complications, which only worsened and resulted in her death last month. The majority of the records were maintained at CDS' Miami office which was also Ms. Frias' home. Due to Ms. Frias' sudden death, the CDS Companies' records were not released until recently. Ms. Serra immediately began to review all records and then discovered that the CDS Companies were involuntarily dissolved, less than two weeks ago, on October 4, 2002.

Accordingly, on behalf of the CDS Companies, we request that the CDS Companies be reinstated without penalty. Enclosed herewith are the original executed Uniform Business Reports for the CDS Companies, along with a check in the amount of \$300.00 representing the annual filing fee for both corporations.

If you have any questions or require further clarification, please do not hesitate to contact me. Thank you in advance for your cooperation and consideration with respect to this matter.
