I am writing to request that you research on my behalf a filing that was done ON-LINE before MAY 1, 2004 at your Web site. I specifically hesitated to do so because of being uncomfortable with the process never having done so. But, I thought my only other choice was to drop post card in mail and inquire for application and worried about time factor. I therefore did file on line giving all necessary information including changes of address for the company. I gave my corporate credit card Visa # 4050482150363985 exp. date 12/06 with name Sound Impressions, Inc. Gail E. Heaton, which is my last legal name before remarrying and my new married name is Gail E. Rouillard. *Perhaps the ON-LINE application had been rejected for either the credit card holder name being different, incorrect data entry or a gliche in the system. I would not have even known it had failed until I received a recent post card notifying me that I must file to dissolve the corporation.*

Within days I called the Division and was told that there have been many such complaints. I was told it was most likely a mistake and they transferred me to another extension. However, since then I have tried several times since to file on line since that call but get this computer message says, "you have a filing in the cue".(a copy of this is enclosed for you to see). I cannot file on line and must file now with this letter again. I am requesting that you research what exactly is on this cue because I know that it should reflect my previous attempt to file before the May 1, 2004 deadline. Believe me, once you have paid the price for being late you do not want to make that mistake again. I sincerely am telling you that I did file on line and had changed the registered agent address since my last physical address change in Florida. I am requesting that you charge me only the initial fee of \$150.00 and waive the \$400.00 late fee. In the event that will not do so I have enclosed the monies in two separate checks. I have done so to prevent your office from the automatic dissolution process which will incur even more expense. If you would be so kind to have honored this request you could void the \$400.00 check enclosed, and mail it back to me in the pre-addressed postage paid envelope.
