Dear Sir:

I represent Wayne Guida and Angela Guida who are the sole heirs to the Estate of Angelo Guida, deceased. Mr. Guida owned all of the issued and outstanding common stock of Amadeus Unisex Salon, Inc. The address of the Corporation from July 12, 1993 to May 1, 1994 was Suite 1000-1913 E. Bearass Avenue, Tampa, FL 33613. From May 1, 1994 to September 17, 1997 the address was P.O. Box 18265, Tampa, FL 33679. Mr. Guida was also the Resident Agent of the Corporation and his Resident Agent address was Suite B - 1308 W. Sligh Avenue, Tampa, FL 33604. When this Resident Agent office was closed, Mr. Guida received his mail at 405 S. Manhattan Avenue, Tampa, FL 33609. Shortly after Mr. Guida's death, in 1999, the corporate office and the Resident Agent address were closed and mail was forwarded to 405 S. Manhattan Avenue, Tampa, FL which was Mr. Guida's place of residence. After the home was sold in 2000, all mail was forwarded to Unit 505 - 4950 Gulf Blvd., St. Pete Beach, FL 33706.

Despite Wayne Guida notifying the Post Office of all changes in address, no one ever mailed Mr. Guida any Annual Report Forms or notified Mr. Guida the Corporation would be dissolved for failing to file an Annual Report. Unbeknown to Mr. Guida and his sister, the Corporation was administratively dissolved for failure to file an Annual Report on September 22, 2000.

Since the Corporation is owed money by the liquidating agent, Mr. Guida and his sister want to file a law suit on behalf of the Corporation; however, they have been informed that they have to pay a reinstatement fee of \$1,050.00 to bring the Corporation up-to-date prior to filing a law suit. We respectfully request this reinstatement fee be waived in view of the fact that none of the interested parties were aware that an Annual Report had to be filed.


