**ARTICLE I**

**ARTICLE IV**

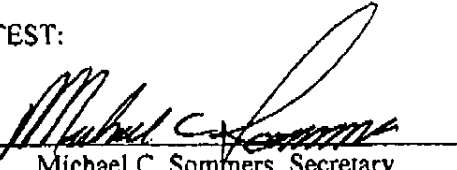

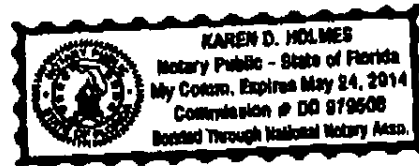
