UNANIMOUS WRITTEN CONSENT IN LIEU OF A SPECIAL MEETING OF THE BOARD OF DIRECTORS AND SHAREHOLDERS OF BENCHMARK ROOFING OF PASCO, INC.

The undersigned, being all of the members of the Board of Directors and all of the shareholders of the above-named corporation, acting without meeting pursuant to Section 607.134 and Section 607.254 of the Florida Statutes and the By-Laws of the Corporation, hereby waive notice of the meeting, and unanimously consent to adopt and take the following actions:

- 1. RESOLVED that the undersigned persons deem it to be in the best interests of themselves and of the corporation that the corporation be dissolved.
