## ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF WATSON & OSBORNE, P.A.

Watson & Osborne, P.A., a professional corporation organized and existing under the laws of the State of Florida (the "Corporation"), pursuant to Section 607.1003, Florida Statutes, hereby files these Articles of Amendment to the Corporation's Articles of Incorporation and certifies as follows:

- 2. The Corporation has fewer than thirty-five (35) shareholders, and pursuant to Section 607.1003(6), Florida Statutes, the owner of a majority of the voting common stock, the only class of stock entitled to vote, by and through the execution and delivery of a form of written consent in lieu of a meeting, dated as of December 30, 2008, resolved to approve and adopt an amendment to the Articles of Incorporation of the Corporation as follows:
