This Statement of Fact is made by Dr. John S. Dluzneski, as former Director, on behalf of THE ANESTHESIA GROUP OF SARASOTA, P.A., a Florida Professional Corporation, which was properly administratively DISSOLVED in 2012, and is being filed in response to: (1) 2019 Reinstatement, filed June 17, 2019, and (2) 2020 Annual Report, filed February 18, 2020.

- (1) The name of the Professional Corporation as originally filed with the Florida Department of State is **THE ANESTHESIA GROUP OF SARASOTA**, **P.A.** (hereinafter the "Professional Association"), Document Number P93000054846;
- (2) The 2019 Reinstatement, filed June 17, 2019, was filed without the knowledge or consent of any person listed on said 2019 Reinstatement;
- (3) The Professional Association was thereafter Administratively Dissolved by the State on December 11, 2019, for failure to designate and maintain a registered agent, as the listed registered agent belonged to another individual or entity;
- (4) The subsequent 2020 Annual Report, filed February 18, 2020, which ostensibly corrects the issues raised by the State's 2019 Administrative Dissolution and again activated the Professional Association, was filed without the knowledge or consent of any person listed on said 2020 Annual Report;
- (5) The Professional Association, in response to both (a) the fraudulently filed 2019 Reinstatement and (b) the fraudulently filed 2020 Annual Report, has filed a Notice of Corporate Dissolution and Termination of Agent Authority in an attempt to stop the current and to prevent any future fraudulent activity from being filed in the name of the Professional Association, as such fraudulent activity has been processed without the knowledge or consent of any person listed on the 2019 Reinstatement or the 2020 Annual Report; and
- (6) No person or persons shall have the power to execute any instrument transferring real property held in the name of the Professional Association, if any, or to enter into any transaction on behalf of, or to otherwise act for or bind the Professional Association, as the Professional Association was properly dissolved in 2012, and needs to remain dissolved.
