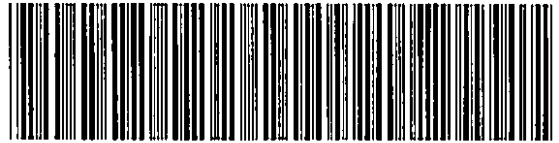

Pursuant to §§ 621.13(1) and 607.1403, of the Florida Statutes, **THE ANESTHESIA GROUP OF SARASOTA, P.A.**, a Florida Professional Corporation, submits the following Articles of Dissolution:

(1) The name of the Professional Corporation as filed with the Florida Department of State is **THE ANESTHESIA GROUP OF SARASOTA, P.A.** (hereinafter the "Professional Association");

(2) The document number of the Professional Association is P93000054846;


(3) Dissolution was initially authorized by the Professional Association via administrative dissolution during the year 2012, however, the Professional Association has since then been fraudulently reinstated twice, most recently via Annual Report filed February 18, 2020, as such, this **Dissolution is authorized as of February 18, 2020, as such Reinstatement was never authorized by the Professional Association;**

(4) The undersigned originally submitted a **Notice of Corporate Dissolution and Termination of Agent Authority** (hereinafter the "Notice") in an attempt to stop the current fraudulent activity and to prevent any future fraudulent activity from being filed in the name of the Professional Association, as such fraudulent activity has been processed **without the knowledge or consent of any person listed on the 2019 Reinstatement or the 2020 Annual Report;** however, said Notice was not filed due to the most recent fraudulent Reinstatement, which was filed while said Notice was being submitted to the State for filing, as such, pursuant to § 607.0123(3) of the Florida Statutes, **the effective date of these Articles of Dissolution is the date of submission of the filing of the Notice – February 24, 2020;**

(5) Dissolution was approved by the Shareholder(s), in the manner required by this Chapters 621 and 607 of the Florida Statutes and the Professional Association's Articles of Incorporation.

**NOTICE OF CORPORATE DISSOLUTION  
AND TERMINATION OF AGENT AUTHORITY

Pursuant to Sections 621.03(2) and 607.1407 of the Florida Statutes, this Notice is filed by **THE ANESTHESIA GROUP OF SARASOTA, P.A.**, a **DISSOLVED** Florida Professional Corporation, for resolution of unknown claims against the Corporation.

(1) The name of the Professional Corporation as filed with the Florida Department of State is **THE ANESTHESIA GROUP OF SARASOTA, P.A.** (hereinafter the "Professional Association"):

(2) The State of Florida administratively dissolved the Professional Association initially in 2012 for failure to file an annual report, and most recently dissolved the Professional Association on December 11, 2019, for failure to designate and maintain a registered agent, as the listed registered agent belonged to another individual or entity; furthermore, a Reinstatement was filed June 17, 2019, **without the knowledge or consent of any person listed on said 2019 Reinstatement**; additionally, a 2020 Annual Report, filed February 18, 2020, which ostensibly corrects the issues raised by the State's 2019 Administrative Dissolution and again activated the Professional Association, was filed **without the knowledge or consent of any person listed on said 2020 Annual Report**;

(3) Information that must be include in a claim is as follows: name and address of claimant, telephone and electronic mail address of the claimant, amount and nature of the claim, and the date or dates upon which the claim is made.

(4) Any claim must be in writing and mailed to the following Address:



(5) Any claim against the Professional Association will be barred unless a proceeding to enforce the claim is commenced within four (4) years of the filing of this Notice.

**This Professional Association was administratively dissolved in 2012. The Professional Association was then fraudulently Reinstated August 1, 2019, and again on February 18, 2020, by an unknown party purporting to be the Registered Agent/Director listed on the last Annual Report filed by the Professional Association in 2012. Any claim originating from the legitimate operation of the Professional Association is likely time barred by Chapter 95 of the Florida Statutes.**

(6) No person or persons purporting to be an Agent of the Professional Association, shall hereafter have any power to execute any instrument transferring real property held in the name of the Professional Association, if any, or to enter into any transaction on behalf of, or to otherwise act for or bind the Professional Association.
