Attached is the 2003 For Profit Corporation Uniform Business Report (UBR) for the above named entity. The taxpayer has included the check for the filing fee of \$150. We realize the report is late, but the original report was never received by the entity.

The fact that the report had not been filed was discovered today by my office when reviewing the corporation's accounting records for the months of January through March. It was determined no check had been written during that time period for the report filing. My associate then called and asked the bookkeeper of the corporation to review all checks written during the month of April for a check to the Department of State. The bookkeeper determined that no check had been written.

Upon determining that the report had not been filed, a copy of the report was downloaded by my associate and taken to Havana so that an officer could review and sign the report and prepare a check.

I respectfully request consideration for abatement of the \$400 penalty assessed for late filing of the report as the entity never received the original copy of the report. Additionally, the corporate officer acted responsibly by reviewing the report and paying the filing fee on the day of discovery of the failure to file.
