

Attached is the 2003 For Profit Corporation Uniform Business Report (UBR) for the above named entity. The taxpayer has included the check for the filing fee of \$150. We realize the report is late, but the original report was never received by the entity.

The fact that the report had not been filed was discovered today by my office when reviewing the corporation's accounting records for the months of January through March. It was determined no check had been written during that time period for the report filing.
