To whom it may concern,

Please help me with the following situation. I had to hire a new accounting firm due to the poor performance of our previous one. I had however prepaid the previous firm to finish all our corporate work including filing our Corporation Annual Report. It therefore is a shock to me to realize that this was not done. We had paid that firm in good faith and expected that they would do the right thing. If they had informed me that there would be any problem at all I simply would have taken care of this important matter myself to avoid the late fee, as I am neither irresponsible nor rich.

Additionally, I am now also dealing with the tragic recent death of my 43-year-old brother. He died just 3 weeks after getting married and adopting his wife's children. Regarding my choice of accountants, in the future I will make sure that the reports are absolutely on time. Let me know if you need any more information from me. Thank you for your help and understanding.
