This notice is submitted by the dissolved corporation named below for resolution of payment of unknown claims against the corporation as provided in Section 607.1407, *Florida Statutes*.

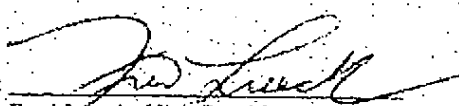
