ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION OF
GARY MARKEL SURPLUS LINES BROKERAGE, INC.

Pursuant to Section 607.1006 of the Florida Statutes, the Articles of Incorporation of GARY MARKEL SURPLUS LINES BROKERAGE, INC., a Florida corporation (the "Corporation"), are hereby amended as follows:

1. The name of the Corporation is GARY MARKEL SURPLUS LINES BROKERAGE, INC.

2. Article I of the Articles of Incorporation of the Corporation is hereby amended to read as follows:

"ARTICLE I - NAME

The name of the corporation is:

Markel Ross, Inc."

3. The foregoing amendment was adopted on November 30, 2006, by the written consent of the shareholders of the Corporation in accordance with the provisions of Sections 607.1003(6) and 607.0704 of the Florida Statutes.
