Pursuant to the provisions of Section 607.1006, Florida Statutes, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation, which Articles of Incorporation were approved by and filed with the Secretary of State of Florida on August 24, 1993, and effective August 24, 1993, document number P93000060148.

1. The following Amendments to the Articles of Incorporation were adopted by the Shareholders and the Directors of the Corporation on the 3rd day of November, 1997, in the manner prescribed by the Florida General Corporation Act.

A. Article I of the Articles of Incorporation is hereby amended to read as follows:

ARTICLE I - NAME


The name of the corporation shall be BT OF


