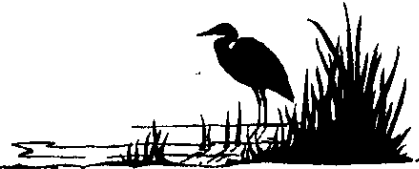

To whom it may concern:

I did not receive the invoice and 2000 UBR in the mail this year. The company name was changed in late 1999.
