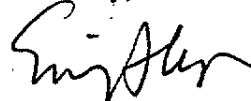

Pursuant to the provisions of Section 607.1006 of the Florida Statutes, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is Dynamic Sales, Inc.
2. The following amendments were adopted by the board of directors:
  - i. Article V. Preemptive Rights of the Articles of Incorporation are deleted.
  - ii. Article VI. Transfer Restrictions of the Articles of Incorporation are deleted.
3. The amendment was adopted on July 16, 2002, in the manner prescribed by the Florida Business Corporation Act by the board of directors without shareholder action and shareholder action was not required.
4. This Amendment shall be effective upon the earlier of its adoption or its filing with the Secretary of State as provided by the Florida Business Corporation Act.
