We are writing to you with respect to our above referenced client. Enclosed please find their check payable to the Department of State in the amount of \$150.

The principal in this corporation who is responsible for all financial matters is June Stark. She is a realtor and has a background in accounting and bookkeeping and has always been very prompt in dealing with any type of federal or state tax matters. She was quite shocked to receive the second notice as Stark Realities, Inc. never received the first notice back in January. Our firm does not prepare the annual report for this client - Mrs. Stark usually assumes responsibility, as the form is relatively simple. It wasn't until receipt of the second notice that she realized that the first notice had never been received. If you review the corporation's record of always paying their annual report timely - I think you will agree this was certainly something out of the ordinary. Certainly when the Florida legislature invoked this "penalty/late fee" of \$400 - they weren't seeking to penalize innocent corporate taxpayers - who would certainly have paid the franchise fee - had they actually received a form to pay it with. Mrs. Stark has advised us that there have been some problems with the Company mail over the past several years. The address shown on the annual report, 5715 Bayberry Lane, is actually a residential area and for occupational license purposes the following address is used: c/o Coldwell Banker, 10120 West Oakland Park Boulevard, Sunrise, Florida 33351. We have enclosed a copy of the federal corporation income tax return (Form 1120S) documenting the fact that this address is used on most tax documents. It is Mrs. Stark's contention that perhaps the first notice, which was addressed to Bayberry Lane, was forwarded by the post office to the corporate address of Coldwell Banker in Sunrise. However, once the report was received by Coldwell Banker it got lost in the "shuffle" of mail in an office of over 40 brokers.
