FIRST: Pursuant to Section 607.1003 of the Florida Statutes, the Articles of Incorporation of Multimedia Communications, Inc. are hereby amended to delete the provisions of Article I as the same now exists, and by substituting in lieu thereof, the following:

ARTICLE I

NAME AND PRINCIPAL OFFICE

The name of the Corporation shall be PROVIDEO SOLUTIONS, INC.
