Dear Leslie Sellers,

I have received a letter from you telling me you are unable to waive the late fee. Would you kindly read the accompanying letters so that you will understand the reason for my being late in my payment to you and for you to please reconsider your decision.

For the past five years I have been trying to open a small complex for older people with special needs. I finally found the right parcel of property and in order to purchase it I had to sell my home in February. Because of a shortage of funds I had to move myself eventhough I was not feeling too good because of my cancer. When I left my past home I left a forwarding address to my office without walls, a small business center sponsored by the Sarasota Vocational School Board for people who were trying to start a new business. Unfortunately we were told at the last minute, March, that the School Board would be closing the facility and I then had to request my mail be sent to this address. I did not receive the form sent by you until July 12 which was past your deadline. I have presently hired West Coast Accounting Inc. so that this lateness will not happen in the future.

I have invested, in this project, over \$450,000 of my own cash and have not received one cent in return and I have completely depleted my funds. It would be an extreme hardship if I had to pay an additional \$385.00 late fee and I beg you to re-consider your request for this late feel
