4. All remaining property and assets of this Corporation have been distributed among its shareholders in accordance with their respective rights and interests.

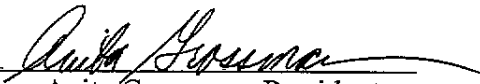

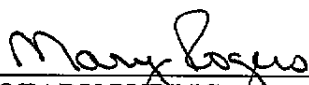
