2. The names and addresses of the members of the Board of Directors, to hold office until his/her successors are elected or appointed have qualified are:

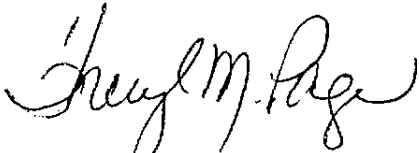
