Please find enclosed an Application for Reinstatement for the above mentioned company along with a check in the amount of \$225.


I spoke with your office on September 26 as I received the notice of Administrative Dissolution or Revocation and was quite suprised. The Annual Report for M.M.I. was sent to your office on May 15, 1996. We did not notice that the check had not cleared, but assumed the report was received as usual. A check of your records will show the company has submitted the report timely since 1993.

The person I spoke with last week indicated that I was certainly not the first person to have this problem this year and I do not feel it is fair for the company to have to pay a \$175 reinstatement fee in addition to the usual \$200 fee for the report. The fee has already been increased to a high amount and the only notice I received that the company was dissolved was the notice. I have never sent these reports certified in the past and did not feel a need to do it this year. This is the first time this has happened and it appears it has happened often this year to many other companies.

I respectfully request that you reinstate M.M.I., Incorporated and have enclosed a check for the annual fee plus a late fee as the original was sent after May 1, 1996. The person I spoke with indicated that this was not a problem as this has affected many companies.

I regret that we did not keep a copy of the original and hope you will be able to accomodate our request.
