WHEREAS , the Articles of Incorporation for the subject corporation were filed on September 15, 1993 and assigned Document Number P930000065240 ; and


WHEREAS , the Corporation in desirous of amending the Articles of Incorporation to change the name to Paul Davis Restoration , Inc of North Pinellas


