The Bureau will not allow a taxpayer to claim a charitable deduction for the contribution of a property interest if the taxpayer has not obtained a written acknowledgment from the donee organization. The donee organization must provide the taxpayer with a written acknowledgment of the contribution within 30 days of the date of the contribution. The acknowledgment must include the following information: (1) the name of the donee organization; (2) the date of the contribution; (3) a description of the property interest contributed; (4) the value of the property interest; and (5) a statement of the donee organization's tax-exempt status.
