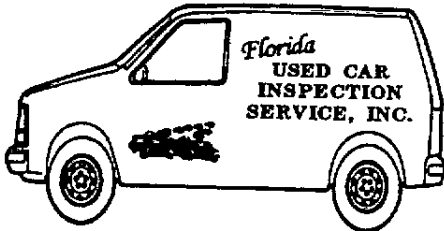

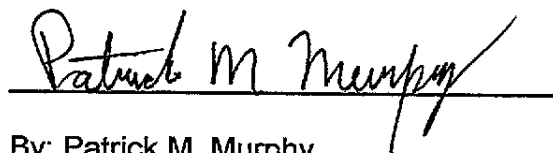
**ARTICLE III – Agreement for Dissolution**
