

Pursuant to the provisions of Section 607.1404, Fla.Stat., the Center for Psychology and Behavioral Medicine, Inc. (the "Corporation") adopts these Articles of Revocation of Dissolution:

- FIRST: The name of this Corporation is The Center for Psychology and Behavioral Medicine, Inc.
- SECOND: The effective date of the dissolution which is being revoked is April 15, 2002.
- THIRD: Pursuant to 607.1404, Fla. Stat., revocation of dissolution was authorized and approved by a unanimous written consent of shareholders of the Corporation on April 16, 2002. The number of votes cast in favor of the Dissolution was sufficient for approval.
- FOURTH: The Articles of Dissolution were authorized by a Written Consent of the Majority Vote of the Shareholders on April 15, 2001. Thus this revocation by a unanimous written consent of the shareholders on April 16, 2002 is authorized in the same manner as the dissolution.
- FIFTH Pursuant to Section 607.0123, Fla.Stat., these Articles of Revocation of Dissolution will take effect on the date of filing, as evidenced by such means as the Florida Department of State may use for the purpose of recording the date of filing.

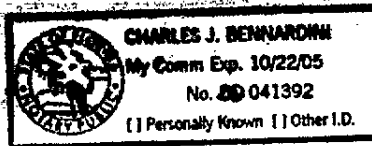
