**ARTICLES OF AMENDMENT TO THE ARTICLES
OF INCORPORATION OF
COILS, SHEETS & TUBES, INC.**

Pursuant to the provisions of Fla. Stat. § 607.1006 (2005), the undersigned, as the President of Coils, Sheets & Tubes, Inc. hereby executes these Articles of Amendment to the Articles of Incorporation of Coils, Sheets & Tubes, Inc. ("Corporation") for the purpose of changing the name of the Corporation to the name set forth below.

I.
