Dear Ms. Payne:

This letter follows up our telephone conversation on October 3, 2001.

I, David Lubecky, hereby request that the Florida Department of State, Division of Corporations, remove my name from the corporate listing as an officer or agent of the corporation named Hammocks, Inc., 101681 Overseas Highway, Key Largo, FL 33033.

During the first week of October, 2001, I learned that I was listed as an officer/director of this corporation on the Department of State's website as an "agent". I understand that this information was taken from the 1999 Annual Report that my brother Gary Lubecky filed with your office on May 4, 1999. My brother listed himself as the President and Registered Agent of the corporation. My brother wrote under the caption "Officers and Directors" that I and his father and his daughter were "agents" of the corporation.

I am not nor have I ever been an officer or director of this corporation. My only role in the corporation is that I allowed my brother to use my name on the corporate bank account as a designated agent to sign corporate checks in the event that he, as the owner and President of the corporation, would have become incapacitated.

My name was added as a designated agent on the corporate bank account in approximately August, 1998. Approximately one year later, I requested my brother to remove my name as a designated agent on the corporate bank account. Apparently, on October 27, 1999, my brother filed a notarized letter with the bank in which the corporate account was maintained releasing me as an agent on the corporate bank accounts. In that letter, my brother also stated that I was "never any officer in the corporation". Also on October 27, 1999, my name was deleted as an authorized signer or agent on the account. I have attached copies of both the notarized letter and the document that indicates that I was removed as an authorized signer or agent on the bank accounts. I have also attached a copy of the officer/director detail screen for this corporation that I received from your office on October 24, 2001.



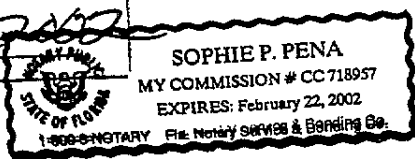
