This letter is in reference to the 2001 UBR relating to our corporation Classics III, Inc., F.E.I. #65-0443006, Doc. #P93000068586.

We have received your second notice to file the 2001 UBR, which we have now enclosed, duly completed and signed. We have also enclosed a check to the Department Of State in the amount of \$150.00.

We have not enclosed the \$550.00 payment requested for a late-filing UBR because we originally sent the First report with a \$150.00 check on 3/22/01. After reviewing our bank account history, we realize that this check has never cleared, indicating that you have never received our form or our check.

As additional information, we also have another corporation, Collins Fish & Seafood, Inc., F.E.I. #59-1211830, whose return & payment was mailed at the same time as the package for Classics III, Inc., and whose check did clear the bank account. We are mentioning this in order to show your Department of our "good faith" and willingness to abide by your regulations. However, an "uncontrollable event" (lost in the mail?) has caused us to be delinquent.
