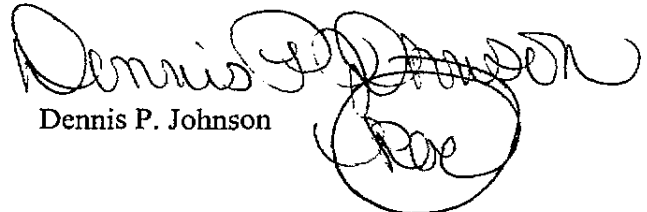

**ARTICLE IV - SHAREHOLDER APPROVAL OF DISSOLUTION**

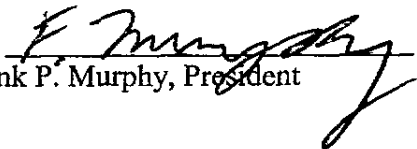

The Articles of Dissolution will be effective upon filing with the Florida Department of State.

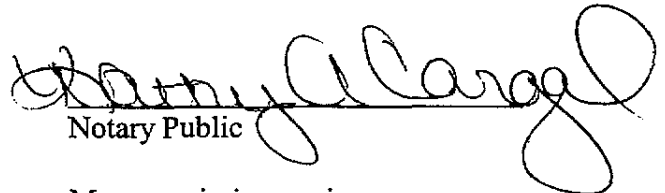
