Please let me explain to the best of my ability. During March I was told by my doctor that I needed surgery and I would be off my feet for a short period of time. Unfortunately, I ended up being in a wheel chair for 6 weeks, with another 2-3 weeks of recuperation after that.

During this time, my husband was doing his very best to take care of paying the bills and keeping up with things. This is difficult as he is not actively involved in my business. He has a regular job, and I am a VERY small business. In fact, I'm the ONLY employee, and I don't even take a salary. I'm that small.

Omission of this form being filed was absolutely an error. I'm not trying to give you excuses, simply telling you what happened. I'm asking that you accept my check for the \$175.00 filing fee. Being required to pay the \$750.00 re-instatement fee would be absolutely devastating to my business. As I stated, I barely earn enough to pay the bills, and don't even take a salary myself. I'm a small business that teaches scuba diving, and business has been very slow here in South Florida due to the weather this year.

I'm asking for your understanding in this matter. Review of past years will show that I have paid the fees on time. Please abate this penalty.
