Please consider this request for waiver of the \$600.00 Reinstatement Fee for Maximum Performance Marine, Inc.


My name is Harvey Amster and I purchased 100% of the issued and outstanding shares of Maximum Performance Marine, Inc. in April 1995 from the former owner, Sunrise Trust. At the time of my purchase I was not aware of the requirement to file an Annual Report with the Department of State. I have recently learned that the corporation was administratively dissolved on August 23, 1996 for failure to file the 1996 Annual Report. The former owner of the corporation apparently filed the 1995 Annual Report on February 1, 1995, prior to the closing on my purchase of the common stock of the company. In that the report, the registered agent, and the officer/director names and addresses were for the former and the corporate registered agent he had appointed.

I can only assume that the information concerning the filing of the 1996 Annual Report was furnished to the former owner or registered agent, whose addresses are completely different from mine. If the former owner or registered agent did, in fact, receive notification of the necessity of filing the 1996 Annual Report, they did not forward it to me. At no time did I ever receive notification from the Department of State or anyone associated with the former owner of the corporation.

Based upon the foregoing, I respectfully request that the \$600.00 Reinstatement Fee be waived in this case. I am enclosing my check in the amount of \$1,565.00 to cover the Annual Report fees between 1996 and 2005 in anticipation that this request for a waiver will be approved.
