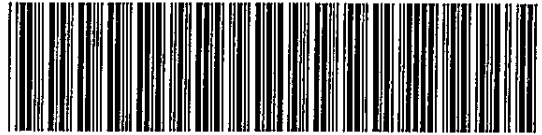



Pursuant to the provisions of Section 607.1006, Florida Statutes, the undersigned, being the President of Avior Technologies Operations, Inc., a for-profit Florida corporation, submits the following Articles of Amendment to its Articles of Incorporation:


FIRST: The name of the corporation is Avior Technologies Operations, Inc. (the "Corporation").
