obligations of this position.

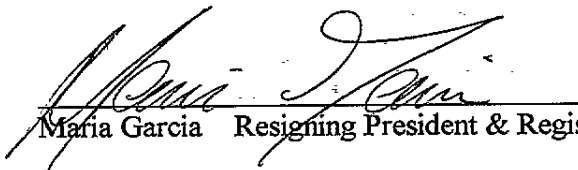

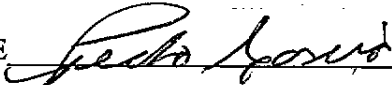

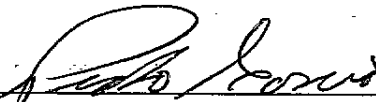
