With regard to the notice received indicating it to be the "SECOND NOTICE" for the annual report, I would like to advise you this was the first one I received. This could, perhaps be due to the fact that you show a non-current address on the form. Although I filed several reports this year (for 1996) which included our new address and also submitted to you a change of address, I see that the old address is still appearing on the form.

Because this company never received the first notice through no fault of its own, I don't think this penalty should be enforced in our case.

The penalty of \$385 is rather unreasonable nevertheless. Penalties of this magnitude are the kind that could drive a small business to simply dissolve; in which case you will get less future revenue.

I am enclosing \$165 and hope you will accept this explanation as it is in fact the sole truth in the matter.
