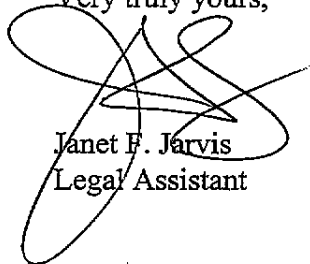

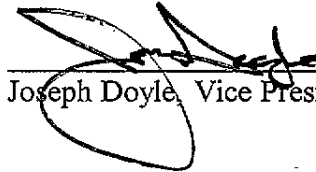
Pursuant to Section 607.1402, Florida Statutes, this Florida profit corporation submits the following Articles of Dissolution:
