Dear Sir or Madam:

I filed my 1997 Profit Corporation Annual Report on April 15, 1997 by US mail and enclosed my \$185 fee plus the additional \$8.75 for a Certificate of Status. Accordingly, I was dismayed to have received a Second Notice indicating a \$550 fee was now due.

I have discovered my original check for \$193.75 never cleared my bank, and so presume my filing was lost either in the postal system or in your office. I have enclosed a signed copy of the second notice filing and a check for \$550. However, I find the revised fee rather excessive, and think it a little suspicious that my report is suddenly lost just when this excessive penalty is newly imposed, especially since I had no problems in the past. Unfortunately, I realize too late that requesting a Certificate of Status is rather useless if the report itself or the payment is mislaid, even if it ultimately turns up if after the initial due date. I'm sending this by Fedex for that reason, but I believe your office needs to reevaluate it's handling of these reports. Under the current system, unless a report is transmitted via a method with return receipt, there is substantial incentive for an overzealous employee to mishandle the filing since the result is the State of Florida receives almost triple the original filing fee.
