NAME: The name of this corporation is changed from FLA\CPA, PA to



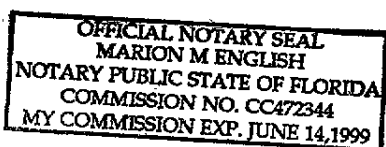


