Per my earlier conversation with Trevor Brumbley, Division of Corporations, we formally request an abatement of the late fees assessed against this corporation in its current application for reinstatement.

In early 1997 the officers of this corporation decided that it was time to change accounting firms from our previous accountant (who resided outside of the state) to a local, in-state accounting firm. The primary reason for this change was to have a closer proximity to guidance as well as having a source with greater familiarity of the laws of the state of Florida.

Through recommendations, we chose the accounting firm of Gary L. Lamalie, PA, CPA. Subsequently all important papers including the corporate annual report were delivered to his office. At about this same time my father became ill and it was necessary for him to under go major surgery. As you can imagine my thoughts were more upon his recovery than on the status of this corporation.

Through discussions with the accounting firm, we were lead to believe that all of our paperwork was in proper order and that we were in good standing with all state and federal authorities. Consequently, it came as quite a shock when we recently received the letter of administrative dissolution from your offices.

For obvious reasons we have discontinued our association with the accounting firm of Gary L. Lamalie, PA, CPA.

At Genovese Investment Corp. we take our responsibilities to the state of Florida and the Federal government quite seriously. As such procedures have been enacted to ensure this does not happen again.
