ARTICLES OF AMENDMENT OF
THE ARTICLES OF INCORPORATION
OF
ITEL, INC.

- A. The name of the corporation is IteI, Inc. (the "Corporation").
- B. The Articles of Incorporation were filed with the Florida Secretary of State on November 12, 1993.
- C. An amendment to the Articles of Incorporation was adopted on May 30, 2008, by the shareholders and the Board of Directors of the Corporation to amend ARTICLE I of the Articles of Incorporation in its entirety to read as follows:

"ARTICLE I - NAME

The name of this corporation shall be LETI, Inc."

There are no other amendments to the Articles of Incorporation, except as stated above.
