Yesterday I learned, quite by accident, that I am named as a Director of the above corporation. At no time was I ever asked to be a director, nor was I ever informed that I was being listed as a director. This was done totally without my knowledge or consent. The only connection I had with US Steel Motorcycles, Inc. was a large loan, from my Pension Plan, which never was repaid in any manner and which Sunny Steel later converted to a stock certificate. This is also worthless.

To this date, I still do not know the financial particulars of where the money went or the legal status of this corporation. Thank you for your assistance in this matter.
