1. Articles of Incorporation of ALEXANDER'S POOL SERVICE, INC., is amended to read as follows:

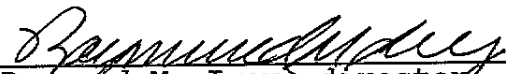
ARTICLE I

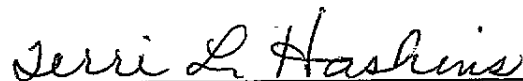
