


The undersigned officers of Jefferson Bank of Florida, Miami Beach, Florida, do hereby certify that the Board of Directors of said financial institution approved and proposed to the shareholder thereof, an amendment to Article I of the Articles of Incorporation as set out herein, and that thereafter on the 26th day of November, A.D. 1996, the holder of all of the outstanding capital stock of said corporation approved such amendment in compliance with Section 607.1006, Florida Statutes, and with the Articles of Incorporation and bylaws of said corporation. There is only one class of stock, and the holder of all of the outstanding shares of such capital stock, which was sufficient for approval, approved the amendment changing the name of the corporation to Colonial Bank of South Florida and amending Article I of the Articles of Incorporation so that, effective as of the 3RD day of January, A.D. 1997, in lieu of its present language it shall read:

## Article I

The name of the corporation shall be Colonial Bank of South Florida and its place of business, now known as its initial place of business, shall be 301-41st Street in the City of Miami Beach, in the County of Dade, and the State of Florida.
