

I recently discovered that my corporation has been dissolved as of 10/4/02 for non-filing of the annual report. Prior to this time we had moved from our location on East Bay Drive to our current location on Starkey Road.—We filed a change of address with the Postal Service and should have received the annual report form, second notice or Notice of Dissolution. We received none of these. However, the name of the Corporation is Jepal Inc. DBA Nushine. We believe the new postman possibly did not recognize the name Jepal and therefore returned the form. It is also quite possible that the form didn't even go to the East Bay location as we have determined from the Website That the address is listed as E Bau. Drive, rather than East Bay Drive. During this time that we did not know we were dissolved, we continued to act as a corporation and filed both Federal and State Corporate returns.

I am enclosing Jepal, Inc. DBA Nushine's corporate check in the amount of \$450.00 to cover the annual filing fees for 2002, 2003 and 2004. I am requesting a waiver of penalty inasmuch I feel failure to receive the notices was beyond my control and qualifies as reasonable cause.
